

Why you should attend this course ...

FOR THE FIRST TIME IN DECADES a new federal *Fisheries Act* and associated supporting regulations are being introduced. This change brings a significant shift in emphasis from habitat protection to the protection of fisheries - imposing new penalties, new duties for proponents to consult with Aboriginal communities and new rules governing the prosecution and defence of water pollution charges.

To maintain compliance, you need to know about how the new changes to Canada's oldest pollution law will affect your organization - particularly in cases of competing jurisdictions, approvals, and in instances where a spill, or unintentional deposit of a deleterious substance, prompts a ministry visit.

Municipalities should also be aware of the responsibilities and implementation schedules imposed by new federal Water Effluent Systems Regulations introduced last December.

These changes to federal legislation are being introduced alongside similar initiatives at the provincial and municipal levels.

In Ontario, for example, new requirements for the implementation of drinking water source protection plans (SPPs) are just beginning to bite, imposing pro-active safeguards that will affect development and other planning decisions.

In Toronto and other municipalities, stringent sewer-use by-laws continue the trend, with the imposition of strict limits on effluent leaving industry facilities. Your facility is required to comply with these limits or be subject to surcharge or other compliance agreements.

How Ontario's new Waste Reduction Act and Strategy could impact you

OF THE APPROXIMATELY 12 MILLION tonnes of waste generated in Ontario every year, only 25 per cent is being diverted.

Ontario's IC&I (Industrial, Commercial & Institutional) sectors, which are collectively generating 60 per cent of the province's wastes, are recycling only 13 per cent.

That is about to change.

In June 2013, the Ontario government introduced its new *Waste Reduction Act*. In so doing, it signalled its intent to abandon a 10-year experiment with "extended producer responsibility" in favour of an "individual producer responsibility" (IPR) approach that will make waste generators individually responsible and environmentally accountable for diverting designated wastes from landfill.

What does that mean for you?

Once passed, this legislation will have a significant impact on both industries, municipalities, distributors and retailers - establishing new IPR requirements for the diversion of designated end-of-life products, and enabling the setting of new standards related to waste diversion.

Paper and packaging supplied into the IC&I sectors are expected to be the first wastes to be designated, likely followed by new recycling standards for end-of-life vehicles and organics.

Under the new act, producers could either set up "producer-controlled intermediaries" or deal with third party intermediaries who would broker, arrange or facilitate the provision of waste reduction services for them.

While it is thought that this approach will allow producers greater flexibility in deciding how to meet the new standards, it is already clear that these changes - backed up by strict fines and penalties and a 'beefed up' Waste Reduction Authority with new powers to enforce the rules - have the potential to radically change how companies, organizations and municipalities will meet the challenge of waste management.




